

LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).






This chart shows the total general purpose revenue Evergreen Union Elementary School District expects to receive in the coming year from all sources.

The total revenue projected for Evergreen Union Elementary School District is \$14,260,098, of which \$10,460,899 is Local Control Funding Formula (LCFF), \$1,822,303 is other state funds, \$1,010,681 is local funds, and \$966215 is federal funds. Of the \$10,460,899 in LCFF Funds, \$1,149,892 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

This chart provides a quick summary of how much Evergreen Union Elementary School District plans to spend for 2021-22. It shows how much of the total is tied to planned actions and services in the LCAP.

Evergreen Union Elementary School District plans to spend \$13,965,266 for the 2021-22 school year. Of that amount, \$12,453,299 is tied to actions/services in the LCAP and \$1,511,967 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:



Increased or Improved Services for High Needs Students in the LCAP for the 2021-22 School Year

In 2021-22, Evergreen Union Elementary School District is projecting it will receive \$1,149,892 based on the enrollment of foster youth, English learner, and low-income students.
