




This chart shows the total general purpose revenue Evergreen Union Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Evergreen Union Elementary School District is \$15,763,582, of which \$12,436,389 is Local Control Funding Formula (LCFF), \$2,022,400 is other state funds, \$756,901 is local funds, and \$547,892 is federal funds. Of the \$12,436,389 in LCFF Funds, \$1,504,583 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Increased or Improved Services for High Needs Students in the LCAP for the 2023-24 School Year

In 2023-24, Evergreen Union Elementary School District is projecting it will receive \$1,504,583 based on the enrollment of foster youth, English learner, and low-income students.
