Transportation Services:

1. Evergreen Union School District covers 575 square miles of land. As such, students need support in getting to school. Historically, students who reside within the Evergreen Union School District boundaries and attend Evergreen Elementary School (Transitional Kindergarten, Kindergarten, and First through Fourth grades) as well as Evergreen Middle School (Fifth through Eighth grades) are eligible for transportation services, provided they follow the rules and regulations listed in the EUSD Parent/Guardian/Student Handbook for Transportation. It is not mandatory for the District to offer transportation; it is a privilege and service offered by the District, authorized by the Governing Board of Trustees. Students who attend Bend Elementary School are not provided with transportation as the local housing community is located within walking distance of the school. Any students who select to attend one of our schools on an inter-district transfer, are not provided with transportation services as they have selected to attend our schools, which are out of their local area.

As described above, EUSD provides transportation services to all students at Evergreen Elementary and Evergreen Middle Schools - this includes students with disabilities and homeless children and youth.
